If you do not have a valid sellers permit, please contact the California State Board of Equalization at (951) 680-6416. You may apply for a resale number at 3737 Main Street, #1000, Riverside, CA 92501-3395. All Operators/Vendors are required to file a sub-location on your sellers permit for each event outside of your normal business. This is typically a dash (-) after your resale number. Use 224 N. Euclid Avenue - Ontario Town Square. This can be done through the number and address above at no charge. Doing so helps ensure that the city or county event you are participating in receives the local sales tax it is due. By doing this it would eliminate the need for you to complete the Local Tax Allocation for Temporary Sales Locations and Certain Auctioneers form (BOE-530-B).
